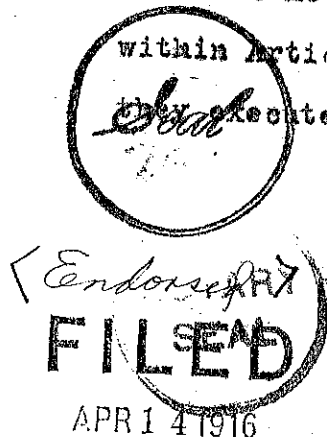

ARTICLES OF INCORPORATION
OF
EUREKA WOMANS CLUB.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned all of whom are citizens and residents of the State of California, have heretofore associated ourselves together, not for pecuniary profit, but for social and benevolent purposes, do hereby incorporate under and by virtue of the laws of the State of California, and we do hereby certify;

First: That the name of the Corporation hereby formed is and shall be "EUREKA WOMANS CLUB."

Second: That the purposes for which said corporation is formed are as follows;

To form a recognized center for social and mental culture, to further the education of women for the responsibilities of life, to encourage all movements for the betterment of society and to foster a general public spirit in the community.

To acquire and maintain suitable and permanent accommodations, meeting places and halls for the members of that certain club, known as "Eureka Womens Club" in the City of Eureka, County of Humboldt, State of California, to purchase, receive, take, lease, hire and own lands, tenements, hereditaments; to purchase, lease, hire, erect, equip, furnish, own and maintain halls and buildings and parts of halls and

buildings; to rent lands, buildings, parts of buildings, stores, offices and rooms to persons, societies, associations, and corporations; to own, buy and sell, mortgage, hypothecate, and pledge real and personal property, to borrow and loan money with or without security; to issue bonds and other forms of security, and generally to do any and all things necessary or proper to achieve and carry out the object and purposes hereinabove mentioned.

Third: That the place where the principal place of business of said corporation is to be transacted is and shall be the City of Eureka, County of Humboldt, State of California.

Fourth: That the term for which said corporation is to exist is fifty years from and after its incorporation.

Fifth: That the number of Directors of said Corporation is and shall be Nine (9) and the names and residences of those elected for the first year and to serve until the election and qualification of their successors, are as follows:
